2. Affiliate Program

Four new affiliate applications were received, as well as additional information on two outstanding applications.

#### Outstanding Applications:

The Town of Vernon shared additional information on their application, confirming that they were applying on behalf of the town's 250th committee. Subcommittee members agreed that this application should be moved to the approval vote.

End Witch Hunts shared that they have been working with a DAR chapter to connect witch trial descendents to the American Revolution and that they are holding a remembrance ceremony for witch trial victims at Connecticut's Old State House. D. Schander and J. Mancini noted that it may be more appropriate for the DAR chapter to become an affiliate, as End Witch Hunts appears to be connecting to the 250th for one program. Subcommittee members were in agreement that, in lieu of requesting additional clarification from this group, the application be denied and that End Witch Hunts consider encouraging their DAR partner to become an affiliate.

#### New Applications:

Two new applications were flagged by staff for discussion - Plainfield CT 250 and Middlesex Parish 250 - as both applicants responded "no" to one or more Values Alignment questions. Additional information was solicited from both organizations by staff.

Plainfield CT 250 represented the town's committee, and responded "no" to one question as they felt they were not in a position to judge the actions of others. Subcommittee members agreed that this was not grounds to deny the application, and moved it to the slate of applications to approve.

Middlesex Parish 250 is a newly formed community committee, and was not yet prepared to share a response to the questions. Subcommittee members agreed to table this application pending additional information.
