2. America250 Update

Jason Mancini noted that his takeaway from the America250 convening in Washington, D.C. was that state and territory commissions are approaching this work in lots of different ways, and generally with minimal funding. There is potential for funding from the Department of the Interior, which is administering \$150M of funds that has been allocated to America250.

Arienne Orozco attended the National Association of Secretaries of State conference last week, where there was more conversation about the 250th than in years past. She confirmed that SOTS offices have differing levels of involvement, and that funding seems to be a concern in most states.

Gonzalez will add a question to the affiliate application requesting additional information if any responses are "no" to cut down on follow up in the future.

#### 4. Updates on Affiliate Outreach

Upcoming plans for affiliate outreach include: a virtual information session in October with the Connecticut Library Association and inclusion in an upcoming CT Humanities grants newsletter. Additional discussion on strategies to expand the program included a specific ask to current affiliates. There may be a possibility to create some sort of incentive to recruit additional affiliates. To facilitate this, we would need to add a question to the application form asking whether they were referred/how they found out about the program. Another option may be to have a competition by town - the most affiliates in a single town/city.
